2010 Annual Awards Dinner

The Nineteenth Annual Awards Dinner honoring our Public Safety Officials was held on October 21, 2010 at The Piedmont Driving Club. This was the second year in a row at the new venue, and we had a record turnout with over 250 people in attendance.

Dispersed among the crowd were many senior officials from each of the major police and fire departments we service. We thank them for their attendance and support.

The invocation was given by Board member Stephen Boyd, followed by the state of the club by Chairman Bill Lellyett.

A total of sixteen awards were presented by two of our Board Members, Margaret Stickney and Chairman Emeritus A.B. Martin.

The Betty Moore Award for outstanding community service went to Sergeant James Ebb with the City of Atlanta Police Department. He is the oldest member of the department and at the age of 70, serves as the Day Watch Administrative Sergeant at the Atlanta Airport

Since last year's banquet we have been called on twice to assist the families of officers killed in the line of duty. Corporal Chadwick LeCroy with the Georgia State Patrol was shot and killed by a suspect following a high speed chase on December 27, 2010, and Rick Daly with the Clayton County Sheriff's Office was gunned down on July 20, 2011 while attempting to serve a warrant on a suspect for armed robbery and assault charges. with the same professionalism and enthusiasm as when he first joined the force in 1986.

Nine of the sixteen awards went to police officers and firefighters from Cobb County for their heroic actions in the wake of the historic flooding in metro Atlanta in September 2009. The stories of daring rescues told by these brave men, including members of the Cobb Police Department's Underwater Search & Rescue Team and the Cobb Fire Department's Special Rescue Unit, captivated the audience.

Six other awards went to recipients for four separate incidents. Three detectives received awards for their heroism during a standoff with an armed suspect following a domestic violence call. Another honoree was a young firefighter who single-handedly rescued a baby from a dangerous house fire. Another was a detention officer who was stabbed by an inmate but still managed to subdue him until help arrived. Another was a firefighter who responded to a residence with a woman in cardiac arrest and then ended up having to subdue her grief-stricken husband who was armed and suicidal.

Their emotional and moving stories were truly memorable for everyone in attendance and reminded us all again why we take part in this great organization.

This year's dinner will be at The Piedmont Driving Club on October 20, and we hope for another record turnout.

We have also come to the aid of an officer seriously injured in the line of duty. Investigator Patrick Apoian with the City of Atlanta Police Department seriously injured by a hit-and-run driver following a traffic stop on July 21, 2011. We have been working with Investigator Apoian, who is also the founder of Humble Heroes, and his wife Sandra to assist them with their financial needs while he is unable to work. He is currently undergoing outpatient therapy at the Shepherd Center and is working toward a full recovery. I am also happy to report that the man accused of running over him finally surrendered to authorities on August 15 after nearly a month on the run. Our thoughts are with Investigator Apoian at this time and we pray for a speedy recovery.

We hope that we can continue to give back to those in uniform and their families to show appreciation for their incredible courage and continued service to our community.

Again, thanks to all of you for your continued support.

The 300 Club of Atlanta is a non-profit, non-political, independent organization of three hundred citizens of the City of Atlanta and surrounds whose general purposes are:

"To receive funds and property, to invest and reinvest the same and to disburse and distribute the same as voluntary, gratuitous and charitable gifts and contributions to or for the benefit of dependent widows and children of law enforcement officers and fire fighters, who, while in the employ of the City of Atlanta or in the employ of other municipal corporations and political subdivisions in the geographical area of the City of Atlanta, as this corporation may authorize in the future, have lost their lives in the line of duty and to those law enforcement officers and fire fighters and their families who in the opinion of the Board of Directors of the corporation have shown extreme courage, valor and devotion to duty in the performance of their duty; or have been wounded or injured in the line of duty or have extreme or unusual need; provided,

however, that the selection, from the class above-mentioned of the recipients of such gifts and contributions, and the determination of the amount thereof, shall rest in the absolute discretion of the Board of Directors of the corporation.

In furtherance of the foregoing purposes, the corporation shall have and exercise any, all and every power which a non-profit corporation organized under the provisions of the Code of the State of Georgia for charitable purposes could be authorized to exercise, but not any other power. No part of the funds or property of the corporation shall inure directly or indirectly to or for the benefit of any member thereof, and no part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation."
