ANNUAL AWARDS DINNER

The 22nd Annual Awards Dinner Honoring our Public Safety Officials was held on October 17th, 2013 at The Cherokee Town Club.

We had a total of 20 honorees, including a K-9 team that included their dogs: Marko, Duke, and Zoom. Three other group awards included DeKalb County police officers who helped a man held at gunpoint inside an O'Reilly's Auto Parts, Cobb County officers who rescued an elderly woman from a fire, and East Point firefighters who saved children from a burning home.

Four other awards went to individuals for their bravery, quick attention, and in one situation, true humanitarian efforts. From daring flood rescues, chasing

We have donated approximately \$1,000,000 in these areas since our inception.

In the past 21 months alone, we have given over \$100,000 to seven families in need of our assistance. In each of those cases, we offered immediate financial support

and comfort to the injured first responder or, in the event of a fatality, to the family. Continued financial support was offered where needed.

We continue to be financially strong, and our membership base continues to grow. Thanks to all of our members, because without you, we would not be able to do what we do.

On a final one, as most of you may already know, we lost a great leader in this community earlier this year. Our founder, A.B. Martin, passed away in January. We will miss him dearly.

The 300 Club of Atlanta is a non-profit, non-political, independent organization of three hundred citizens of the City of Atlanta and surrounds whose general purposes are:

To receive funds and property, to invest and reinvest the same and to disburse and distribute the same as voluntary, gratuitous and charitable gifts and contributions to or for the benefit of dependent widows and children of law enforcement officers and fire fighters, who, while in the employ of the City of Atlanta or in the employ of other municipal corporations and political subdivisions in the geographical area of the City of Atlanta, as this corporation may authorize in the future, have lost their lives in the line of duty and to those law enforcement officers and fire fighters and their families who in the opinion of the Board of Directors of the corporation have shown extreme courage, valor and devotion to duty in the performance of their duty; or have been wounded or injured in the line of duty or have extreme or unusual need; provided, however, that

the selection, from the class above-mentioned of the recipients of such gifts and contributions, and the determination of the amount thereof, shall rest in the absolute discretion of the Board of Directors of the corporation.

In furtherance of the foregoing purposes, the corporation shall have and exercise any, all and every power which a non-profit corporation organized under the provisions of the Code of the State of Georgia for charitable purposes could be authorized to exercise, but not any other power. No part of the funds or property of the corporation shall inure directly or indirectly to or for the benefit of any member thereof, and no part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation."
